RECOGNITION ORDER

WHEREAS, in terms of **Section 15 (1)** of the NCTE Act, 1993, **LITTLE STAR EDUCATION SOCIETY, VILLAGE: MAKRONIA BUJURG, STREET/ROAD: DR.HARI SINGH GOUR NAGAR, TALUKA/MANDAL: NAGAR PALIKA MAKRONIA, TOWN/CITY: SAGAR DISTRICT: SAGAR-470004, MADHYA PARDESH (WRCAPP201660231)** had submitted on **16.08.2016** the application to the Western Regional Committee of the NCTE for grant of recognition/permission to **B.T. INSTITUTE OF EXCELLENCE, SURVEY NO. 72, VILLAGE: HARI SINGH GOUR NAGAR MAKRONIA, STREET/ROAD: MAKRONIA, TALUKA/MANDAL: SAGAR, TOWN/CITY: SAGAR, DISTRICT: SAGAR-470004, MADHYA PRADESH** for **B.A.B.Ed. 4 years integrated course**.

AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee in its **275th meeting held on May 1-2, 2017** is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the **B.A.B.Ed. integrated programme**, such as, infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

NOW, THEREFORE, in exercise of the powers vested under **Section 15 (3) (a)** of the NCTE Act, 1993 and in accordance with the Regulations, 2014, the Western Regional Committee, NCTE hereby grants permission to **B.T. INSTITUTE OF EXCELLENCE, SURVEY NO. 72, VILLAGE: HARI SINGH GOUR NAGAR MAKRONIA, STREET/ROAD: MAKRONIA, TALUKA/MANDAL: SAGAR, TOWN/CITY: SAGAR, DISTRICT: SAGAR-470004, MADHYA PRADESH** for conducting **B.A.B.Ed. integrated programme of 4 (Four) years** duration with an annual intake of **50 students (one basic units of 50)** from the academic session **2017-18**.

The institution shall gradually move towards becoming a composite institution as per clause 8(1) of the NCTE Regulations, 2014.

The institution shall comply with various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

The institution shall make admissions only after it obtains affiliation from the examining body in term of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

The institution shall ensure that the required number of academic staff for conducting the course is always in position.

The recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, State Government etc. as applicable.

The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with annual statement of accounts duly audited by a Chartered Accountant.



WHEREAS, recognition was granted to the institution, namely, B.T.I. E. (BABULAL TARABAI INSTITUTE OF EXCELLENCE), LITTLE STAR EDUCATION SOCIETY, DR.HARI SINGH GOUR NAGAR, VILLAGE: MAKRONIA BUJURG, SAGAR- 470004 MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.ED. (CO-ED).course vide order dated 04.05.2009 for an annual intake of 100 students.

AND WHEREAS, one Shri Pawan Dubey had filed a PIL in the Hon'ble High Court of Madhya Pradesh at Jabalpur. The Hon'ble High Court had directed to inspect all B.Ed. institutions in the State of Madhya Pradesh. Since, the institutions are existing institutions, the inspection was to be conducted by NCTE Hqrs. u/s 13 of the NCTE Act.

AND WHEREAS, the Inspection (U/s-13) was conducted by NCTE Hqrs. on 26.03.2015.

AND WHEREAS, the AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 17.01.2015 and the reply was received on 12.02.2015.

AND WHEREAS, Revised Recognition order was issued to the institution on 31.05.2015.

AND WHEREAS, the Deficiency Letter was issued by the NCTE HQRs. to the institution on 27.07.2015 and the institution submitted reply received on 21.09.2015 in WRC.

AND WHEREAS, the VTR alongwith file of the institution were received from NCTE Hqrs. in WRO on 03.02.2016.

AND WHEREAS, the matter was placed before the WRC in 252nd Meeting held on May 09-10, 2016 and the Committee decided that "... The NCTE Hqrs. had issued a Deficiency letter to the institution on 27/07/2015 and the institution replied on 21/09/2015. The points are as under :-

- The institution has not submitted originally certified copy of the land documents.
- The institution has not submitted Building Completion Certificate from a Govt. Engineer.
- The institution has not submitted original FDRs of Rs. 3 and 5 lakhs in joint names.
- The sitting capacity in the reading room is only 14 which is grossly insufficient.
- The institution has not submitted the staff approved by the affiliating body.

Hence, Show Cause Notice be issued under section 17 on the above mentioned grounds."

AND WHEREAS, Show cause notice was issued by the WRC to the institution on 12.05.2016 and the reply of Show cause notice was not submitted by the institution.

AND WHEREAS, the matter was placed before the WRC in 255th Meeting held on June 22-24, 2016 and the Committee decided that "... On the basis of the observations of the inspection team of the NCTE Hqrs. (inspection under Section 13 of the NCTE Act, 1993), Show Cause Notice dt. 12/05/2016 was issued. No reply has been received from the institution.

Hence, Recognition is withdrawn under Section 17 from the end of the next academic session."

AND WHEREAS, the Withdrawn order was issued by the WRC on 12.07.2016.

AND WHEREAS, appeal filed by the institution u/s-18 of the NCTE Act, 1993 on 07.09.2016.

AND WHEREAS, Appeal order dated 18-01-2017. Decision Direction of the Appellate Authority ... Appeal Committee concluded to confirm the withdrawal order dated 12.07.2016.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

AND WHEREAS, the institution filed WP No. 1703/2017 before the Hon'ble High Court of Madhya Pradesh Principal seat at Jabalpur. The Hon'ble High Court vide Order dated 19-05-2017 issued by the Hon'ble High Court were placed before Appeal Committee by the NCTE in its 10th meeting held on 30.05.2017.

AND WHEREAS, Appeal order dated 10-07-2017, Decision Direction of the Appellate Authority "...The Committee concluded that the appeal deserves to be remanded to WRC, Bhopal for restoring the recognition for B.Ed. programme withdrawn earlier vide WRC order dated 12.07.2016.

NOW THEREFORE, the Council hereby remands back the case of B.T.I.E. (Babulal Tarabai Institute of Excellence), Sagar, Madhya Pradesh to the WRC, NCTE, for necessary action as indicated above.

AND WHEREAS, the matter was placed before the WRC in 279th Meeting held on June 10-11, 2017 and the Committee decided that "... The appellate authority vide its order dated 10.07.2017 has on the one hand stated that the withdrawal order issued by the WRC on 12.07.2016 was on valid grounds not disputed by the appellant himself while on the other hand it has remanded the case to WRC for restoring recognition for the B.Ed. programme withdrawn earlier.

Hence, recognition is restored.

NOW THEREFORE, the recognition of B.T.I.E. (BABULAL TARABAI INSTITUTE OF EXCELLENCE), LITTLE STAR EDUCATION SOCIETY, DR.HARI SINGH GOUR NAGAR, VILLAGE: MAKRONIA BUJURG, SAGAR- 470004, MADHYA PRADESH for conducting B.Ed. course with an annual intake of 100 students (two basic units of 50 students each) is hereby restored.


